President Jonathan then invited AG Heman to introduce speaker Mr. Jonathan Cheung to talk about "Horticulture - A Sustainable & Food Safety Venture".

Our speaker Jonathan is currently the Executive Director of PT. Bintangdelapan Holtikultura, which is a "Horticultural" company headquartered in Indonesia, deploying the advanced/world class farming techniques/technologies to produce "Healthy sea-food & vegetable products". Jonathan is the co-founders and owners of this company. He is responsible for the International Division which is based in Singapore.

Jonathan is also the Principal Advisor to Impact Corporate Training, focusing on leveraging Jonathan's rich and proven FSI industry domain knowledge and experience to enhance the offerings of Impact Corporate Training capabilities across Asia Pacific region.

Jonathan Cheung was the Executive Director/Regional Head of Citibank Strategic Sourcing & Procurement Services covering the 15 countries across Asia Pacific; and prior to Citibank, Jonathan has been working for MNCs including companies: EDS, PwC Consulting and HP as theirs Financial Services Industry (FSI) Global/Regional Director.

Jonathan has over 27+ years experience in the developing and implementing major financial service solutions under a multi-vendor environment for leading financial institutions in Europe, US and Asia-Pacific. Jonathan has deep experience advising senior management at leading financial institutions on business/technology related issues. Jonathan has been based in UK, US, Canada, Germany, France, Australia, Singapore, India, Indonesia, South Korea, Japan, Hong Kong, China and Taiwan.

His experience includes Strategic Sourcing, Procurement, Costs Transformation, Re-engineering, IT strategies, Operations blueprint and complex/large scale systems integration suppliers/vendors management, business development, business consulting, and business process re-engineering for a number of high profile global/regional/domestic clients.

Jonathan holds a **post-graduate degree** in **Management** from Aston University and **a bachelor's degree** in **Computer Science** from the University of London, and is a member of **four professional bodies**, the Chartered IT Professional (CITP), the British Computer Society (MBCS), the Institute of Analysts & Programmer (SMIAP) and the Singapore Computer Society (SMSCS).

Jonathan began by introducing his company Bintangdelapan Bintang is Stars and Delapan is no. 8, which is his lucky number, and so being used in the logo of the company. He then posted some challenges that the industry needs to address, they are:

- 1. Access to recycle energy
- 2. Organic products, how can you tell if it is Real or Not?
- 3. Food origin and food safety
- 4. Corporate Social Responsibility.

About his company, it was established in 1994, but in Oct 2013, it is under new management. She is a division under PT. Anta Tirta Kirana Group who is a well established Plastic End to End Manufacturer as well as Diary Products Trader in Indonesia.

The Farming operation site is situated @ 1000m above sea level near West Java which is about 160km from Jakarta. It contains:

- **❖** 25HA/250,000 sq m/62.5Arces.
- the actual production site of the food produces
- the R&D center
- deploying the latest high tech farming approach which is greenhouse + Aquaponic as well as implement the barrier packaging
- ❖ 1st large scale commercial "Aquapnoic Farm" with 128 greenhouses
- deploying the Biomass energy approach from the farming wastes and clever use of Solar Panels technology

There is another Eco Showcase site (10HA/100,000 sq m/25Arces) is situated at West Java which is about 60km from the Jakarta, with this site, they would like to:

- combine the Eco tourism and awareness of health foods approach
- * education center with greenhouse farm stay with at least 10-12 villas type of accommodation as well as camping facilities
- * showcase of the greenhouse farming & Aquaponic approach
- target both consumer and corporate sectors
- ❖ health food bistro and kitchen to showcase the health food cuisines

The farm deploys sustainable farming approach by combining the state of the art "Green House" Technology, with Aquaponic approach, plus Barrier Packaging.

- ➤ The state of the art "Green House" Technology required to control the farming environment, thus able to control the harvesting cycles, duration and hence, quality of the produces.
- ➤ The "Aquaponic" approach to achieve the Eco friendly farming approach and thus able to produce Health vegetables and fruits as well as sea-foods in full recycle friendly environment.
- ➤ The "Barrier Packaging" approach is used to maintain freshness of the produces during transportation for both domestic and export markets.
- > To achieve Biomass Energy, the farm recycle their farming wastes

Jonathan then introduced their "Aquaponic" Flow Bed Technique, with water flowing from a centralize fish tanks to bed of vegetables / fruits across a single greenhouse or multiple greenhouses. He also compared the framing techniques of Hydroponics vs Aquaponic as follows:

Farming Techniques	Advantages	Disadvantages		
Organic	- Become the presumption that healthier method of growing food, hence produce better quality and tasting produce - Uses organic wastes as fertilizer as well as natural pest control approach	-Requires more land as compare to conventional approach - Higher costs to produce food and certify crops - Agribusiness is quickly replacing small-scale organic operations		
In-Organic Hydroponics	-High volumes and food are produced in a small space - Has potential for year-round production if controlled	-Highly dependent on costly manufactured/mined fertilizers - Large wastage of water even recycle, due to toxic created during water recycle - High rate of failure due to small margin for error - Large wastage of water		
Recirculating Aqua	- High biomass of fish produced in a small space			
Aquaponic	-Have all the advantages of the above techniques and plus: Reuse of fish waste as nutrients for plants - Fish don't carry the pathogens (e.g. E coli and Salmonella) found in warm – blooded animals - Imitates a natural cycle of life and is the most sustainable of the four techniques - Consistent fish biomass in the fish tanks lets plant growth thrive	-Operator must have knowledge of both fish and plant production - Major fluctuations in fish stocks in the tank can disrupt plant growth		

The produce of their farm including ginger, lettuce, tomato, broccoli, sawi, potatoes, cucumbers, asparagus, Shitake, Portobello, oyster, eel, tilapia, and catfish.

With this approach, Jonathan and his company believes that they met their challenges head-on with:

- Greenhouse + Aquaponic farming

- Providing supports to 500+ farmers/fishermen in West & Central Java
- Maintaining the Farming Heritage
