On 9/6, there will be a TV programme on Rotary called "Rotary in your heart".

Sergeant-at-arms Laurence announced our collection which was HK\$2,100.00. Kishu announced the arrangement relating to typhoon. If signal no.8 shall be hoisted by 9:00a.m. on the day of Rotary meeting, that meeting will be cancelled automatically.

Kishu then introduced our speaker who actually needed no introduction. He was the senior partner of law firm PC Woo & Co. and a director of several listed companies, an OBE, a JP, and a great singer. He made a lasting impression on the writer because he was a school prefect of the secondary school that the writer attended, and he had been a leader ever since.

Moses talked to us, first of all, about PP Edwin. PP Edwin gave Moses his briefing when he first joined Island East.

He then talked about the remuneration paid to non-executive directors. As you all know, the role of the non-executive directors in listed companies is the overseer of the benefits of the minority shareholders and inevitably this will lead to conflict with the interest of the majority at some stage.

On 21/3/2000, in the Financial Times, Miss Maitland wrote an article tilled "Part-time directors deserve higher salary". The reason behind this was that despite the "part-time" basis, the duty was onerous and highly valuable. The survey in UK in 2001 had shown increase of 4 to 6% in non-executive directors' remuneration but in the same period, there was an increase of 8 to 10% in executive directors' pay.

In HK, there was little record on non-executive directors' remuneration. Mosses said that it could range from HK\$20,000.00 to HK\$200,000.00 per annum.

What were the criteria for "independence". There were 3 conditions:

- (i) not exceeding 1% shareholding in the company concerned;
- (ii) no management function;
- (iii) not related to majority shareholders.

They exercise the "watch-dog" function through Audited Committee and if a conflict arises, they will form an independent committee to advise minority.

So, really, how much should non-exclusive directors be paid? The yardstick would appear to be: high enough to compensate for their efforts but not so high as to lead to a compromise of their functions (after all, they are paid by the company concerned). There is also a debate going on as to whether they should be entitled to stock options.

Lastly, Moses rounded off by these famous words: "if you pay peanuts, you only get monkeys!"

PP Con thanked our speaker in his usual witty manner. President then declared the meeting adjourned with a toast to HKNE.

It is a very sad duty for me to express the deepest condolence on behalf of myself and the members of the Rotary Club of HK Island East to the family of our late Past President Edwin Tao who passed away peacefully on the 28th May 2002.

Edwin was born and educated in China and came to Hong Kong to take up the post of general manager of American Engineering Corp. in air conditioning for many long years. Later, he joined Rankine & Hill (HK) Limited until his untimely death.

Edwin and his family have been known to me since 1960 when I first joined the Rotary Club of HK Island East. Throughout these four decades, we had been working closely together in serving our club as well as the community. Our two families have good connection in sports and social events.

Prior to his presidency of our club in 1960/61, he had gone through all the ranks as officers and directors of our club and also served as chairman of the Past Presidents Council for many long years.

He had served twice as president of a well known organization of his profession in Hong Kong as President of Engineering Society of Hong Kong in 1965/66 and president again of the Hong Kong Institute of Engineers in 1986/87. Besides, he played an important role with the Chinese University of Hong Kong and Free Masonry.

A man of great wisdom and dedication, Edwin touched the hearts of all those who knew him. His passing will be a tremendous loss to our club.


