### 1. **Xian and Beijing Visit**

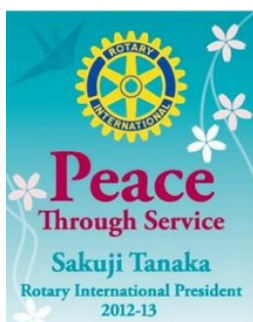

President Nancy introduced the speaker today- our honorable PDG Anthony Hung and the followings are the amendment and changes of Council Legislation:

**Topic of today-Council on Legislation (“CoL”),****About the Council on Legislation**

- Council on Legislation (“CoL”), Rotary’s “parliament”, meets every 3 years to and act upon all proposed enactments and resolutions submitted by clubs, district conferences, the General Council and Conference of Rotary International (“RI”) in Great Britain & Ireland, and the RI Board. The Council itself also makes proposals.

- CoL is an important part of Rotary’s governance process. Board of Directors sets policies for RI, the Council is where Rotary Clubs have their say in the governance of the association
- Each district sends a representative to the Council every 3 years which reviews proposed legislation.
- Clubs and districts are entitled to submit legislation to the CoL. There are 2 types of legislation :
  - Enactments – which seek to change the constitutional documents (the RI Constitution, the RI Bylaws, and the Standard Rotary Club Constitution); and
  - Resolutions – which do not seek to change the constitutional documents. (Note, the Recommended Rotary Club Bylaws are not considered part of the constitutional documents and may only be changed by RI Board action.)
- 200 Enactments and Resolutions were proposed to the CoL for consideration this year.
- The statistics are as follows:

### Club Administration

#### **13-01 To amend the provisions for club report**

- The certified club report which every club must certify to Rotary International shall now also be circulated to the club members. (17.020 of RI Bylaws)

#### **13-02 To provide that the club secretary shall be a member of the board**

#### **13-03 To amend the provisions for club officers**

##### *Section 4 – Officers*

- The club officers shall be a president, the immediate past president, a president-elect, and a secretary, and may include one or more vice-presidents, all of whom shall be members of the board. The club officers shall also include a treasurer, and may include a sergeant-at-arms, all of whom may be members of the board as the bylaws shall provide.

#### **13-06 To amend the qualifications for club president**

##### *Section 5 – Election of Officers*

- A candidate for the office of president shall have served as a member of his/her club for at least **one year prior to being nominated** for such office, except where service for less than a full year may be determined by the district governor to satisfy the intent of this requirement.

#### **13-08 To exempt former members of a club from a second admission fee**

- Former member of this club rejoining the same club is not required to pay a second admission fee.

### Attendance Requirement

#### **13-12 To amend the attendance provisions to include service requirements**

##### *Article 9 – Attendance*

- Section 1 – Each members should attend this club’s regular meetings **or** engage in this club’s service projects, events and activities.

- Members whose attendance at regular meetings, engage in club's service projects, other club events and activities are considered valid.
- A member shall be counted as attending a regular meeting if the member is present for at least 60 percent of the meeting, or is present and is called away unexpectedly and subsequently produces evidence to the satisfaction of the board that such action was reasonable, or makes up for an absence.

**13-12 To amend the attendance provisions to include service requirements**

Section 4 – *Termination – Non-attendance*

- Attendance Percentages. A member must:
  - attend or make up at least 50 percent of club regular meetings or engage in club projects or other club activities and events for at least 12 hours in each half of the year, or a proportionate combination;
  - attend at least 30 percent of this club's regular meetings or engage in club projects in each half of the year (assistant governors, as defined by the board of directors of RI, shall be excused from this requirement).

**13-14 To amend the provisions for non-attendance**

Section 4 – *Termination – Non-attendance*

- Attendance Percentages. A member must:
  - attend or make up at least 50 percent of club regular meetings in each half of the year;
  - attend at least 30 percent of this club's regular meetings in each half of the year (assistant governors, as defined by the board of directors of RI, shall be excused from this requirement).
  - If a member fails to attend as required, the member's membership may be subject to termination unless the board consents to such non-attendance for good cause.

**Excused Absence and Attendance Record**

**13-22 To amend the provisions for excused absences**

Section 3 – *Excused Absences*

- If the leave is for a medical reason that extends for more than 12 months such leave may be renewed by the board for a period of time beyond the original 12 months. Such leave for medical purposes shall not be counted as an absence for purposes of attendance records of the club.

**13-23 To amend the provisions for excused absences**

Section 3 – *Excused Absences*

- A member's absence shall be excused if the aggregate of the member's years of age and years of membership in one or more clubs is 85 years or more and the member has notified the club secretary in writing of the member's desire to be excused from attendance and the board has approved.

**13-27 To amend the provisions for RI officers' excused absences**

Section 4 – *RI Officers' Absences*

- A member's absence shall be excused if the member is a current officer of RI or a Rotarian partner of a current officer of RI.

**13-28 To amend the provisions for calculating attendance records**

Section 5 – *Attendance Records*

- When a member whose absences are excused under the provision of subsection 3(a) of this article fails to attend a club meeting, the member and the member's absence shall not be included in the attendance records.
- All excused members' attendance shall not be included in the attendance record.

## Club Meeting

### **13-32 To provide for satellite clubs**

#### *Article 4 - Membership in Clubs*

- No person shall simultaneously hold active membership in more than one club, other than in a satellite of that club.
- Every member shall have the privilege of attending the regular meeting or satellite club meeting of any other club except for a club that previously terminated the membership of said person for good cause.
- A satellite club shall be located in the same locality as the sponsor club or in the surrounding area.
- Satellite Club Membership
- Section 5 – Satellite Club Membership. Members of a satellite club shall also be members of the sponsor club until such time as the satellite club shall be admitted into membership of RI as a Rotary club.
- Section 6 – Dual Membership. No person shall simultaneously hold active membership in this and another club other than a satellite of this club. No person shall simultaneously be a member and an honorary member in this club. No person shall simultaneously hold active membership in this club and membership in a Rotaract club.

## Membership

### **13-42 To allow home makers to become active members**

- The enactment was passed but did not get 2/3 majority, therefore get rejected.

### **13-43 To allow people who have not worked or interrupted their work to be active members**

#### *Section 2 – Composition of Clubs*

- A new classification has been introduced under Composition of Clubs whereby a person having interrupted employment or having never worked in order to care for children or to assist the spouse in their work.

### **13-48 To amend the provisions for termination of membership**

#### *Section 5 – Termination – Other Causes*

- The board may terminate the membership of any member who ceases to have the qualifications for membership in this club or for any good cause by a vote of not less than two-thirds of the board members present and voting, at a meeting call for that purpose.
- 

### **13-49, 13-51 & 13-52 To amend the provisions for transferring and former Rotarians**

- The following was added to Article 4.030 and Article 7 Section 4(a). The transferring or former members changing clubs should be asked to bring a letter of recommendation from previous club.
- Section 4(b) – This club shall provide a statement whether money is owed to this club when requested by another club with respect to a current or former member of this club being considered for membership in the other club. If such statement is not provided within 30 days of being requested, it shall be assumed that the concerned member does not owe any money to this club.
- A member may propose to active membership a transferring member or former member of a club (previous qualifications deleted).
- The transferring or former members changing clubs should be asked to bring a letter of recommendation from their previous club.
- Club shall provide a statement whether money is owed to the club. If such a statement is not provided within 30 days of being requested, it shall be assumed that the concerned member does not owe any money to this club.

**13-53 To allow honorary members to wear the RI emblem**

Section 2 – *Honorary Members*

- Every honorary member of a club shall be known as an honorary Rotarian, and shall be entitled to wear the emblem, badge, or other insignia of RI as long as that member holds honorary membership in the club.

**District**

**13-54 To remove the limitation on the number of e-clubs in each district**

- The board may assign an e-club to any district without regard to the boundaries of such district.

**13-104 To amend the provisions for locality of an e-club**

- The locality of an e-club shall be worldwide or as otherwise determined by the club board.

**Meeting**

**13-58 To change the term “district assembly” to “club leadership training seminar”**

- Term “District Assembly” has been renamed “District Training Assembly” after debate.

**13-62 To revise district conference voting procedures**

- When voting on the selection of the governor-nominee, election of a member and alternate member of the nominating committee for director, composition and terms of reference of the nominating committee for governor, or election of the club representative and alternate representative of the district to the council on legislation, all votes from a club with more than one vote shall be cast for the same candidate or proposition. For votes requiring or utilizing a single transferrable ballot with three or more candidates, all votes from a club with more than one vote shall be cast for the same ordered choices of candidates.

**Object of Rotary**

**Both 13-64 & 13-65 have been referred to the Board for their consideration:**

**13-64 To add a fifth part to the Object of Rotary to include the involvement and development of youth**

**13-65 To add a fifth part of the Object of Rotary to include the development of service and leadership in youth**

**13-69 To amend the fifth Avenue of Service**

- New Generations has been renamed as **Youth Service**.
- Youth Service, the fifth Avenue of Service, recognizes the positive change implemented by youth and young adults through leadership development activities, involvement in community and international service projects, and exchange programs that enrich and foster world peace and cultural understanding.

**Governor**

**13-90 To create the title of governor-designate**

- The enactment was passed with amendments. The DGN who is elected 24 months – 36 months prior to the day of taking office will from 1 July 2013 be called “District Governor-nominee Designate”.

**13-95 To amend the provisions for election of a governor at a district conference**

- The following sentence was added to Article 13.020.13 Ballot at District Conference for election of Governor-nominee : “Each club shall designate one elector to cast all of its votes.”

**13-98 To amend the provisions regarding concurrences to challenges**

- The following sentence was added to end of Article 13.020.9 Concurrence to Challenges : “A club shall concur with only one challenging candidate”. Apparently, in a lot of districts, clubs endorsed multi candidates and this prevents them from so doing from 1 July 2013.

**13-100 To amend the provisions for vacancy in the office of governor**

- This is a new enactment dealing with vacancy in the office of governor. A new section 6.120.3 was added to Article 6.120 “The nominating committee for governor will select one available past governor to be named vice-governor. The role of the vice-governor will be to replace the governor in case if temporary or permanent inability to continue in the performance of the governor’s duties”. A Past District Governor will take over as vice-governor as set out above.

**Rotary International – Corporate Governance**

**13-103 To increase the number of clubs that may participate in a pilot project from 200 to 1,000 clubs**

- This enactment was passed to increase the number of clubs from 200 to 1,000.

**13-104 To revise the provision for locality of an e-club**

- The locality of an e-club shall be worldwide or as otherwise determined by the club board rather than by the RI board.

**13-109 To revise the Board’s authority to change district boundaries**

- The RI Board is authorized to change the district boundaries if the district membership is below 1,200 or less than 33 clubs. These districts may be eliminated or merged with another district. The number of members was reduced from 1,200 to 1,100 to provide those smaller districts with room to increase membership to the required level.

**Operations**

**13-119 To allow clubs not in the United States or Canada to decide if the Rotary magazine will be distributed as a print copy or through the Internet**

- This enactment was proposed by 20 districts. Each member shall now have the option to choose to receive either a printed copy by mail or an electronic copy via the internet where available.

**13-120 To remove the travel reimbursement policy from the RI Bylaws**

**13-121, 13-122, 13-123 & 13-125 To revise the travel reimbursement policy**

- The above have been referred to the board.

**RI Finance & Per Capita Dues**

**13-126 To increase per capita dues**

- 17.030.1 *Per Capita Dues*.
- Each club shall pay to RI per capita dues for each of its members as follows : US\$26.50 per half year in 2013-2014, US\$27 per half year in 2014-2015, US\$27.50 per half year in 2015-2016, and US\$28.00 per half year in 2016-2017 and thereafter; provided that each club shall pay semiannually to RI a minimum of US\$265.00 in 2013-2014, US\$270.00 in 2014-2015, US\$275.00 in 2015-2016, and US\$280.00 in 2016-2017 and thereafter. Such dues shall remain constant until changed by the council on legislation.



- A US\$1-a-year increase in per capita dues to be paid by club to Rotary International was approved for the next 3 consecutive years starting 2014-15. US\$54 in 2014-15; US\$55 in 2015-16 and US\$56 in 2016-17.

**13-128 To eliminate the minimum semiannual dues paid by each club**

- Before this enactment was passed, each club must pay a minimum dues for 10 members even if the club membership is less than 10. As of 1 July 2013, there will not be any minimum amount payable to RI by any club.

**13-130 To reduce or waive per capita dues in the event of natural disasters**

- 17.030.3 *Return or Reduction of Dues.*
- The board may return to any club such portion of said dues as the board deems just. Upon request, the board may reduce or postpone the amount of per capita dues payable by a club whose locality has sustained serious damage due to natural or similar disasters.

**13-134 To revise the dues payable by RIBI and to eliminate the RIBI contribution to the unrestricted net assets of RI**

**RI Meetings**

**13-136 To reduce the provisions regarding regional conferences of RI**

**Legislative Procedures**

**13-138 To revise district endorsement of club legislation and conference voting to include district resolutions meetings**

- Legislation from a club must be endorsed by the clubs of the district at a district conference, a district resolutions meeting or RIBI district council. Where time does not allow legislation to be submitted to the district conference, a district resolutions meeting, or RIBI district council, the legislation may be submitted to the clubs of the district through a ballot-by-mail conducted by the governor. Such ballot-by-mail shall follow the procedures in section 13.040 as closely as possible. All legislation delivered to the general secretary shall be accompanied by a certificate from the governor stating that it has been considered by the district conference, a district resolutions meeting, RIBI district council, or in a ballot-by-mail and has been endorsed. No district should propose or endorse more than a total of five items of legislation per council. (7.030 of RI Bylaws)

**13-138 To revise district endorsement of club legislation and conference voting to include district resolutions meetings**

- A conference of Rotarians of each district shall be held annually at such time and place as agreed upon by the governor and the presidents of a majority of the clubs of the district. The conference dates shall not conflict with the district assembly, the international assembly, or the international convention. The board may authorize two or more districts to hold their conferences together. Further, the district may hold a district resolutions meeting at a time and place determined by the governor and with 21 days clear notice provided to all clubs in the district. (15.040 of RI Bylaws)

**13-141 To amend the definition of defective legislation**

**13-149 To revise the procedures for nominating Council representatives**

- All votes from clubs with more than one vote shall be cast for the same candidate, failing which the votes from such clubs shall be deemed to be spoiled votes.

**13-150 To amend the provisions for electing a Council representative**

- The governor shall also appoint a qualified Rotarian who is a member of a club in the district as the alternate representative.

## Resolutions

- 13-153** To request the RI Board to consider proposing legislation to the next Council on Legislation to introduce a new category of membership: associate membership
- 13-157** To request the RI Board to consider encouraging the adoption of the second Object of Rotary as the guiding principle for vocational service
- 13-166** To request the RI Board to consider adding peace and conflict resolution activities to the areas of International Service
- 13-167** To request the RI Board to consider establishing RI New Generations Service Day
- 13-168** To request the RI Board to consider designating the Rotary Leadership Institute as an RI affiliate or as a structured program of RI
- 13-174** To request the RI Board to consider amending the Standard Interact Club Constitution to promote gender equality – Amended
- 13-183** To request the Trustees to consider granting an exception to the eligibility guidelines for grants for families affected by disasters
