Rotary Information

Grant Management Seminar (GMS)

The Rotary Foundation (TRF) supports the effort of Rotary International (RI) to achieve world understanding and peace through international programs.

Grants are an integral part of TRF. To understand TRF, one must understand how Grants work. It is only natural that GMS is a component of the District Rotary Foundation Seminar (DRFS).



For D-3450, the DRFS was held on Saturday 27 November, 2021 in the morning, and GMS in the afternoon.

Under the provisions of the Rotary Foundation's program, Clubs desiring to participate in Grants programs must be certified annually. Attendance at a GMS is a mandatory requirement if we are to apply for Grants in 2022-23.

A Club only needs one representative; yet, it is recommended that both the Club Presidentelect and Rotary Foundation chair attend the GMS.

Successful Grant projects will have the following characteristics:

- · Meet community needs;
- · Involve partners with same vision;
- Maintain frequent partner communication;
- Develop implementation plan;
- Are sustainable beyond the Grant;
- Maintain proper stewardship of funds.

At the GMS, we have learned about:

- Background information: District Grant & Global Grant;
- How to qualify our Club to receive TRF grant funds and successfully manage a TRF grant;
- How to design projects and work with international partners;
- How to prepare Clubs to implement the memorandum of understanding (MoU);
- Stewardship and conflict of interest aspects which are often overlooked.

We encourage Club members to attend the GMS, and report afterwards. In so doing, knowledge on Grant management can be cascaded to every Club member. After the GMS, if we are still interested, we can peruse the RI website which offers a wealth of information. The following publications may interest you:

- Grant Management Manual
- GMS Leader's Guide
- DRFS Manual

In recent years, TRF raises awareness on conflict of interest, which:

- Exists when a Rotarian benefits financially or personally from a grant;
- Results in benefit: direct (the Rotarian benefits) or indirect (an associate of the Rotarian benefits);
- Can be a matter of perception.
