Rotary Information

The Sponsor of a New Member

The bylaws of Rotary clearly outline the procedure for a prospective member to be proposed for Rotary club membership. The "proposer" is the key person in the growth and advancement of Rotary. Without this sponsor, an individual will never have the opportunity to become a Rotarian.



The task of the proposer should not end after submitting a name to the club secretary or membership committee. Rotary has not established formal responsibilities for proposers or sponsors; however, by custom and tradition, these procedures are recommended in many clubs. The sponsor should:

- Invite a prospective member to several meetings prior to proposing the individual for membership.
- Accompany the prospective new member to one or more orientation, informational meetings.
- Introduce the new member to other club members each week for the first month.
- Invite the new member to accompany the sponsor to other clubs for the first makeup meeting to learn the process and observe the spirit of fellowship.

- Ask the new member and spouse to accompany the sponsor to the club's social activities, dinners or special occasions.
- Urge the new member and spouse to attend the district conference with the sponsor.
- Serve as a special friend to assure that the new member becomes an active Rotarian.
- When the sponsor follows these guidelines, Rotary becomes stronger with each new member.
