Seven of us will be going to Niigata for their 85th Anniversary on 26 April 2025.


We will have 4 cars joining our 31 May 2025 northbound travel for Hong Kong vehicles fellowship to Zhuhai and Zhongshan.

Rotarian Zoe joined our club early last year. She has over 20 years of experience in finance, specializing in traditional and digital asset management. She began her career as a stock analyst at Sun Hung Kai Financial Group and transitioned into asset and portfolio management so that she could engage more with people.



Asset management is a diversified

field, where she was able to interact with multiple projects globally. June last year, The Securities and Futures Commission of Hong Kong had provided licenses for digital asset trading platforms. 10 licenses were granted, and the field was expanding rapidly. February this year, more than 6,000 experts came to Hong Kong to discuss digital asset investment.



Rotarian Zoe shared the "Rainbow Pattern", which uses logarithmic regression to model Bitcoin's price trends over time. Color bands overlay the curve, indicating market sentiments from "Fire Sale" to "Maximum Bubble Territory."

The 2008 financial crisis caused widespread distrust in the banking sector. In 2009, Bitcoin was created as a decentralized, secure way to manage money without relying on traditional banks.

This innovation led to the rise of cryptocurrencies like Bitcoin and Ethereum, offering people more control and security over their finances. Rotarian Zoe sees recent governance changes as a positive trend, conducive to Hong Kong's economic growth. She believes governance significantly impacts digital asset growth, so we should always stay informed about news when considering investments in digital assets.

Investing in digital assets involves trading happening in different time zones through global monitoring, automated systems, and robust risk management. The cash-and-carry method, which entails buying cryptocurrency from different markets taking advantage of price discrepancies and different currencies, can help reduce volatility exposure. These strategies help create a balanced and effective investment portfolio.

Digital asset management is still relatively new, and the regulations provided by the Securities and Futures Commission will give traditional investors greater confidence in these products. Rotarian Zoe recommends that portfolios be diversified across different asset classes to balance risk and returns.
